BEK is still unable to commit to broadcasting rodeos over the 4th of July due to other scheduling conflicts. Kelly mentioned that it went much smoother between them & the committees in 2024. Chuck asked if they would be doing different rodeos in 2025. Nate explained that BEK considers the broadcast by performance not necessarily the entire the rodeo. Nate feels that if there is a committee that really would like to have BEK there then we need to encourage those committees to reach out to BEK & see what they need to do to help make it happen. Chuck also wanted to know if there was still going to be a subscription requirement to watch the rodeos. Nate will follow up with this question.
 - b) Rodeo Pay Scott uses a company called Bill.com. It will cost the association a monthly fee and per transaction. Each contestant would be set up as a vendor. This

would include the contestant giving bank & routing numbers for deposits. Questions: how many will sign up for it, who will monitor the money coming in, will all committees need to participate, what will be the expediency of deposits from committees.... The Bill.com contacts are still determining the logistics and fee for setting up an account for the NDRA as one or individually for rodeos. The board agreed we needed more information. Tabled until a later date.
